This has reference to NBA's letters of even number dated 29-03-2018 and 26-03-2021 under which MCA program offered by your Institution was granted accreditation for (2+1) years by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases of MCA programs which were accredited for a period of (2+1) years upto 30-06-2021 in which the Institutions concerned have not been able to apply afresh for accreditation of the programs or if applied, the accreditation process could not be completed due to the current situation arising out of the second wave of pandemic caused by the Corona Virus, the programs would be considered for accreditation of one year after expiry of the validity of accreditation on 30-06-2021 on the basis of the programs meeting the pre-qualifiers. The data submitted by **BMS Institute of Technology and Management, Dodaballapur Road, Avalahalli, Yelahanka, Bangalore-560064, Karnataka** in the Pre-qualifiers has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the program as given in the Table below:
