2. An Expert Team conducted onsite evaluation of the program from 07th to 09th July, 2023. BMS Institute of Technology and Management, Dodaballapur Road, Avalahalli, Yelahanka, Karnataka-560064 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
