Subject: Supplementary Semester Registration Guidelines for B.E. Students Admitted in 2022 – Regarding.

Ref. VTU/BGM/Aca-Cirs/SA/2023-24/3587 Dated 19-10-2023.

The students admitted to the B.E. program in 2022 are granted with an opportunity to register for the supplementary semester.

1. About the Supplementary Semester:


- The Supplementary/ Fast track semester is provided for Not Satisfying Sessional Requirements (NSSR) and Not Satisfying Attendance Requirements (NSAR) students. The student has to pay a special fee prescribed by the Institution to register for a course in the supplementary semester. The supplementary/Fast track semester is provided to help the student in not losing an academic year. It is optional for a student to make use of supplementary/Fast track semester. Supplementary/Fast track semester is a special semester, and the student cannot demand it as a matter of right.
- Ineligible students must mandatorily register for Fast track semester and compulsorily attend all the Fast track classes, for all the courses registered and re-earn the CIE and attendance.
- **Fast Track Semester (Only for students with NSSR/ NSAR with 'NE' Grades)**
Registration of courses – 25th Oct to 27th Oct, 2023
Course work – 29th Oct to 14th Nov, 2023 (Including all Saturdays, Sundays, and general holidays)
Examination- 15th November onwards
Declaration of Results: 3 days after the completion of the examination.


2. Eligibility for Supplementary Semester:

- The course/s for which the student does not possess satisfactory attendance and Continuous Internal Evaluation (CIE) score will be designated as "NE". These students are eligible for re-registration for courses marked as "NE" during the supplementary semester.

3. Rules and Timeline:

- During the supplementary semester, students are allowed to register for a maximum of 16 credits.
- Applications for the supplementary course registration will be made available in the Departments from **25th October 2023**.
- The class timetable will be announced shortly.

- 2. Students Admitted 2022 scheme / regulations :** The students admitted to 2022 scheme shall follow the regulations -2018 i.e. 2022-23 regular and 2023-24 lateral entry students only at affiliated autonomous colleges will have Supplementary Semester and examinations after every even semester examinations. This is an interim arrangement for the students admitted during these years as a onetime measure. The affiliated autonomous are also informed to maintain the University calendar of events while offering this Supplementary Semester and examinations.
